2010 video game

Call of Duty: Black Ops is a 2010 first-person shooter game developed by Treyarch and published by Activision. It was released worldwide in November 2010 for Microsoft Windows, the PlayStation 3, Wii, and Xbox 360, with a separate version for Nintendo DS developed by n-Space. Aspyr later ported the game to OS X in September 2012. It is the seventh title in the Call of Duty series and the sequel to Call of Duty: World at War.

Set in the 1960s during the Cold War, the game's single-player campaign follows CIA operative Alex Mason as he attempts to recall specific memories in order to locate a numbers station set to instruct Soviet sleeper agents to deploy chemical weapons across the United States. Locations featured in the game include Cuba, the Soviet Union, the United States, South Vietnam, China, Canada, and Laos. The multiplayer component of Black Ops features multiple objective-based game modes that are playable on 14 different maps included with the game. Improvements to loadout options and killstreak rewards are made. A form of virtual currency, COD Points, allows players to purchase weapons and customization options for their in-game character, as well as attachments and customization options for their weapon.

Development for the game began in 2009. Whereas Treyarch worked on both World at War and the tie-in video game for the James Bond film Quantum of Solace simultaneously, they focused specifically on Black Ops during this development cycle. Different teams within Treyarch focused

on a certain game mode. Black Ops runs an enhanced version of the IW 3.0 engine used in World at War. The improvements made allowed for bigger campaign levels to be made as well as enhanced lighting. Music was composed by Sean Murray, with licensed music by the Rolling Stones, Creedence Clearwater Revival, and Eminem appearing in the game. Avenged Sevenfold also recorded an original song for the game as well. The marketing of the game began in April 2010.

The game received generally positive reviews from critics with praise for its story, voice-acting, darker tone and multiplayer modes, although some criticized it for its linear gameplay and technical issues. Among other awards and nominations, Call of Duty: Black Ops was nominated Game of the Year by numerous media outlets and award shows, including the Interactive Achievement Awards, British Academy Games Awards, and Spike Video Game Awards. Within 24 hours of going on sale, the game had sold more than 5.6 million copies, breaking the record set by its predecessor Modern Warfare 2 by some 2.3 million copies. The game had sold over 25 million copies worldwide, making it, at the time, the best selling game of all time in the United States.[4][5] and it remains one of the best-selling games of all time. A sequel, Call of Duty: Black Ops II, was released in 2012. Call of Duty: Black Ops Cold War, set between Black Ops and Black Ops II, was released in November 2024.[6][7]

## **The Gateway Pundit, site de extrema derecha conocido por difundir teorías conspirativas electorales, declarará quiebra ante las demandas por difamación**

La empresa matriz del sitio web, TGP Communications, presentará la declaración de quiebra en Florida "como resultado de los ataques legales progresistas-liberales contra nuestra salida de medios", escribió el fundador Jim Hoft en el sitio web.

Las demandas incluyen una presentada por los trabajadores electorales de Georgia Ruby Freeman y Shaye Moss, quienes demandaron a la organización en Misuri, donde está basada, después de que el sitio web difundiera falsamente afirmaciones de que los dos habían estado involucrados en fraude electoral en Georgia.

En un caso separado, Freeman y Moss obtuvieron un fallo de R\$148 millones contra Rudy Giuliani por difundir mentiras electorales sobre ellos y difamarlos. Después del veredicto, el ex alcalde de la ciudad de Nueva York y el abogado de Trump presentaron la solicitud de quiebra, lo que complica si o cómo Freeman y Moss pueden ser pagados.

Gateway Pundit también enfrenta una demanda en Colorado de un ex empleado de Dominion Voting Systems, Eric Coomer, quien alega que el sitio lo difamó al afirmar que arregló la elección en contra de Trump.

Las oficinas electorales han enfrentado oleadas de mensajes de acoso después de que se han publicado historias de Gateway Pundit, a menudo dirigiéndose al personal con lenguaje amenazante y abusivo.

Las demandas por difamación son una estrategia que los grupos a favor de la democracia, las empresas privadas e individuos están utilizando para tratar de hacer responsables a las personas y organizaciones que difunden mentiras electorales, especialmente las que causan daño a las personas como Freeman, Moss y Coomer. Aquellos en la defensa a menudo se refieren a estas

demandas como "lawfare".

Hoft dijo que la empresa que busca la protección por quiebra no es una admisión de culpa o responsabilidad, sino una manera de reorganizarse y consolidar los litigios "cuando los ataques vienen de todos lados". La empresa podrá incorporar los litigios a los que se enfrenta en un solo tribunal, escribió.
