# Disney and Central Florida Tourism District Resolve Legal Dispute

### **End of a Long-standing Dispute**

A long-lasting dispute between The Walt Disney Company and the Central Florida Tourism District has come to an end, with both parties reaching a settlement. Disney had suspended its presidential campaign this year, and the district has been providing municipal services, such as firefighting, planning, and mosquito control, among other things, for most of its five decades.
