Emma Finucane levou ligar para sportingbet terceira medalha dos Jogos Olímpicos de Paris no sprint individual feminino do Velódromo Saint-Quentin ligar para sportingbet Yvelines, já que os ciclista da equipe GB ficaram bem aquém das medalhas.

Apesar de estar ligar para sportingbet suas primeiras Olimpíadas, Finucane foi a chave dos sete dias da corrida nas pistas e ganhou ouro na equipe no primeiro dia do print; bronze nos keirin. No último Dia também fez o Bronze individual durante um único SCRIP: ligar para sportingbet conquista tornou-a primeira mulher britânica ao longo das últimas décadas para ganhar uma medalha num só jogo olímpico desde que Mary Rand conquistou seu Ouro (ou seja...

"Honestamente, é como um sonho", disse o jovem de 21 anos após a final da corrida.

"Obviadamente eu adoraria ganhar essa medalha ligar para sportingbet ouro mas com mais do que poderia sonhar: Ouro e bronze são muito maiores ainda nesta semana!

"Eu chorei. Tive lágrimas felizes, estive exausto e para me levantar todos os dias... Estou muito orgulhoso de mim mesmo! Não acredito que acabou."

Nos 12 eventos de medalhas no velódromo, a equipe GB ganhou um ouro e três pratas.

Enquanto eles desenharam uma medalha ligar para sportingbet branco nos acontecimentos do BMX que tinha sido o ponto forte da campanha Tóquio; Tom Pidcock foi emocionante defesa para seu título olímpico mountain bike (bicicleta olímpica), enquanto Anna Henderson surpresa na provação feminina foram outros destaque

Em termos de resultados, esta campanha será talvez melhor vista como uma calma e não um dramático declínio. A realidade é que este número está no menor nível desde o primeiro ciclo olímpico do Dave Brailsford ligar para sportingbet 2004, quando a equipe GB se anunciou pela primeira vez na velódromo Atenas com duas medalhas...

Desde o pico de desempenho ligar para sportingbet Londres, que viu a equipe GB reivindicar oito medalhas douradas para Rio e os Jogos atrasado Tóquio – no qual seis ouro foram ganhos nas disciplinas do ciclismo - na contagem final da capital francesa também revela quanto terreno tem sido composto por rivais.

Jack Carlin (no topo) da Grã-Bretanha cai na casa ligar para sportingbet linha reta com Muhammad Shah Firdaus Sahrom, Malásia e Shinji Naka no Japão.

O diretor de performance, Stephen Park s foi otimista quando os eventos da pista terminaram:

"Se você conseguir atingir mais do que 50% das suas chances realistas ligar para sportingbet qualquer jogo e depois bater acima dos valores médio".

Neah Evans, competindo no omnium feminino da sessão final talvez tenha resumido melhor.

"Hoje foi uma de duas maneiras", disse ela: ou você ganha medalha e cai."

Esse foi o seu destino, na última volta da corrida de arranhões depois que tocou as rodas com Lotte Kopecky Bélgica e também Jack Carlin's como ele esticou cada seno para reivindicar bronze no keirin masculino. Como outros antes dela Evans lutou contra ela novamente ligar para sportingbet um terceiro evento: a eliminação do carro mas seus interesses terminaram rapidamente após ligar para sportingbet queda fora dos trilhos!

Talvez o aspecto mais impressionante da campanha de Finucane foi quão bem seu temperamento se mostrou adequado para a estufa do velódromo parisiense.

"Eu só espero que eu esteja inspirando as crianças a entrar ligar para sportingbet ligar para sportingbet bicicleta e dar uma chance, porque é muito legal", disse ela. "Adoraria mulheres apenas se envolverem com o esporte de corrida".

Finucane admitiu que seu foco tinha sido "para cima e para baixo". "Quando estou neste velódromo, eu sou sobre ele. Espero ter provado isso hoje", disse ela. "Eu não estava realmente chorando à pressão... Eu chorava porque fiquei exausta!

"Minha mente estava me dizendo coisas como: 'Você não pode fazer isso.' A pressão, eu lidei com ela muito bem esta semana". É mais a minha tensão interna e o que queria para mim mesma; minhas pernas gritando comigo mesmo pedindo pra parar de gritar... Eu quis continuar indo embora! Foram muitas emoções".

No primeiro da semifinal do sprint, Finucane foi derrotado pelo eventual campeão Ellesse Andrew de Nova Zelândia. Sob pressão no segundo calor para permanecer na competição a equipe liderou durante grande parte das corridas mas não resistiu à aceleração e ficou ligar para sportingbet disputa por bronze contra Hetty Van De Wouw

Isso provou ser um concurso unilateral e a jovem de 21 anos, da Carmarthen conquistou seu terceiro pódio ligar para sportingbet sete dias. Três medalhas na Olimpíada representam uma volta estelar; não há dúvida que Finucane estará entre aqueles indo para Los Angeles com ambição adicional".

O resiliente Carlin venceu confortavelmente ligar para sportingbet semifinal e progrediu para uma final de keirin na qual ele novamente enfrentaria a aparentemente invencível Harrie Lavreysen dos Países Baixos.

Na ligar para sportingbet semifinal, Hamish Turnbull tentou evitar a queda de Luca Spiegel da Alemanha e caiu no banco para fora do trilho. O seu fato rasgado nos ombros foi o pior seguido por Carlin na final quando ele sofreu um acidente aos metros finais ligar para sportingbet uma pilha abatida à base dele com as últimas esperanças medalhistas perdidas!

"Você tem que aceitar, apenas por causa do nível de competição que você vai deixar alguns na mesa", disse Park.

Ele acrescentou: "O programa de pista aqui tem sido incrível. Para sair com 11 medalhas [no ciclismo], para vir como a nação principal ter ganho o 1.000o medalha (para Team GB), Emma ganhar três Medalhas -a primeira mulher que faz isso ligar para sportingbet 60 anos- e ser competitiva no cada evento é eu acho tanto um grande resultado por cá mas também pelo futuro."
