Relato de investigación: Supuesto hermano de Nikola Joki involucrado en una pelea en el juego de los Nuggets

La NBA y la policía de Denver están investigando un incidente en el que un hombre, supuestamente uno de los hermanos de la estrella de los Nuggets de Denver Nikola Joki, fue visto golpeando a un fanático después de la victoria épica de los Nuggets por 101-99 sobre los Lakers de Los Ángeles en los playoffs de la NBA.

En videos compartidos por TMZ y otros medios, se puede ver al hombre trepando sobre asientos para confrontar a otra persona en el Ball Arena, a quien posteriormente le propina un puñetazo en la cara. TMZ informa que la pelea ocurrió el lunes por la noche, inmediatamente después de que los Nuggets remontaran una desventaja de 20 puntos y tomaran una ventaja de 2-0 en la serie de primera ronda.

Un portavoz de la NBA declaró el martes que la liga está investigando el asunto.

El departamento de relaciones públicas de los medios de la policía de Denver declaró en un correo electrónico enviado a la Associated Press que está investigando el incidente, pero señaló que no se informó del incidente a la policía del lugar o después del juego.

"En este momento, nadie ha denunciado ser víctima de este incidente", decía el correo electrónico. "El Departamento está investigando este incidente, trabaja activamente para identificar a la persona en el video que fue golpeada y alienta a cualquiera que haya estado involucrado o haya sido testigo de esto en primera persona a que se ponga en contacto con el Departamento de Policía de Denver."
