O capítulo do guia libro que detalha a estratégia, recentemente destacado pelo E&E News, descreve a NOAA como 0 uma "operação colossal que se tornou um dos principais motores da indústria de alarme do aquecimento global e, portanto, é 0 prejudicial ao futuro da prosperidade dos EUA". Foi escrito por Thomas Gilman, um ex-executivo da Chrysler que, durante a presidência 0 de Trump, foi diretor financeiro do órgão público superior da NOAA, o Departamento de Comércio.

Gilman escreve que uma das seis 0 principais escritórios da NOAA, a Office of Oceanic and Atmospheric Research, deve ser "desmembrada" porque emite "ciência teórica" e é 0 "a fonte de maior parte da alarme do clima da NOAA". Embora admita que ela presta "funções importantes de segurança 0 pública e empresariais, assim como funções acadêmicas", Gilman diz que os dados do National Hurricane Center devem ser "apresentados de 0 forma neutra, sem ajustes destinados a apoiar qualquer um dos lados no debate sobre o clima".
