A. Definitions and legal conditions

Access to and research on the Site by Individual Users is currently free of charge and is 0 governed by the acceptance of the terms and conditions set forth in these legal norms. The User agrees that the 0 Site may be used for personal use by means of a computer or similar device providing links to the Site.

Supersport 0 reserves all rights to set value in the future for accessing or researching the Site, the entire site or specific 0 parts of it by nature, provided that Users are notified in advance of this paid service.

The user acknowledges and agrees 0 that:

-Supersport reserves the right to modify the definitions and terms quoted in legal terms at any time and to communicate 0 them to Users through a general notice posted on the Site.

– These modified legal terms will constitute the new modified 0 terms that will provide access and research to the site.

B. Basic Concepts Used on the Site:

Como apostar na Lotomania?

Rishi Sunak lanza el manifiesto conservador con recortes de impuestos pero pocas sorpresas

Rishi Sunak ha instado a los votantes a no otorgar a Keir Starmer un "cheque en blanco" mientras presentaba un manifiesto conservador que prometía una serie de recortes de impuestos, pero contenía pocas sorpresas.

"No olviden que Keir Starmer les pide que le den un cheque en blanco, cuando no ha dicho qué comprará con él, o cuánto costará", dijo el primer ministro en un discurso centrado en el Partido Laborista en el circuito de Silverstone en Northamptonshire.

Preocupaciones por los aumentos de impuestos de Starmer

Sunak advirtió que si el Partido Laborista gana esta vez, cambiará las reglas para que estén en el poder durante mucho tiempo. Agregó que si no está claro lo que el Partido Laborista hará, no se debe votar por ellos, y si se está preocupado por los aumentos de impuestos de £2,094 de Starmer, no se debe votar por ellos.

Nuevos elementos fiscales en el manifiesto

El único nuevo elemento fiscal en el manifiesto, lanzado justo antes de que hablara, fue un compromiso de eliminar por completo las cotizaciones nacionales de seguridad social (NIC) de los trabajadores autónomos, junto con la promesa ampliamente anunciada de un recorte de 2p en las cotizaciones nacionales de los empleados, reduciéndolas a 6p desde abril de 2027.

El manifiesto agregó: "Nuestra ambición a largo plazo, cuando sea asequible hacerlo, es seguir

recortando las cotizaciones nacionales de seguridad social hasta que desaparezcan".

Otros elementos sorpresa incluyeron un compromiso reforzado sobre la migración, en el que Sunak dijo que un gobierno "reducirá a la mitad" los números de llegada neta, y una promesa de construir 1,6 millones de nuevas viviendas a lo largo de la legislatura.

Eliminar las cotizaciones nacionales de seguridad social para los trabajadores autónomos, dijo Sunak, sería un incentivo para "los emprendedores, las personas que trabajan duro para ganarse la vida que hacen que nuestra economía crezca".

Otros recortes de impuestos prometidos se habían anunciado con anticipación, como los recortes del impuesto de timbre, aumentar el umbral para recibir el beneficio por hijos y garantizar que las pensiones estatales no estén sujetas al impuesto sobre la renta.
