When is the 2024 WSOP?

The 2024 World Series of Poker (WSOP) returns to its traditional summer timeslot and will take place from Tuesday, May 31 through Wednesday, July 20, 2024.

"We are excited to usher in a new era of WSOP next summer," said World Series of Poker Senior Vice President, Ty Stewart.

2024 WSOP Master of Ceremonies Vince Vaughn

Award-winning Hollywood actor and star of 'Wedding Crashers' & 'Old School' Vince Vaughn will be the 2024 WSOP Master of Ceremonies, with the World Series welcoming some of the best poker players from around the world to Las Vegas.

"I am honored to be selected as the Master of Ceremonies for what is set to be the most anticipated World Series of Poker tournament ever," said Vaughn. "Poker has long been one of my favorite sports, so to be a part of something as historic as the WSOP finally moving to the Strip is an absolute dream."

When is the 2024 WSOP Main Event?

The 2024 World Series of Poker Main Event runs from July 3-16, 2024. There will be four starting flights in this year's Main Event, with five 90-minute levels played on Day 1 with cards in the air from 11 a.m. Late registration closes two levels into Day 2 (approx. 2p.m.)

All starting fields will combine for the first time on Saturday, July 9 for Day 3, and play down to a final table on Day 7 on Wednesday, July 13. The traditional day off returns to the schedule, before the WSOP Main Event champion is crowned across two days - Friday, July 15 and Saturday, July 16.

Where will the 2024 WSOP be held?

The 2024 WSOP will be held at the Bally's and Paris Las Vegas Hotels & Casinos in, Nevada. The new Strip location will be a completely new experience for poker players, with the Series having taken place at the Rio All Suite Hotel & Casino for the last 17 years.

There were already hints that the tournament would move, before it was confirmed at the end of the 2024 World Series during the Main Event.

The two properties are linked, as well as being connected to the wider Las Vegas Monorail, allowing World Series of Poker patrons to travel between the two casinos, as well as several other properties on the Las Vegas Strip including Caesars Palace, MGM Grand, and the Convention Center.

Combined, the two venues have 150,000 square feet of tournament capacity featuring 600 poker tables.

Bally's Las Vegas Hotel and Casino

The future Horseshoe Las Vegas, is currently known as Bally's is owned and operated by Caesars Entertainment. The property originally opened in 1973 and is home to 2,812 rooms and over 68,000 square feet of gaming space. At some point during 2024, it will undergo a multimillion dollar rebranding into the Horseshoe around the 2024 World Series of Poker.

The Event Center will host the TV stage of the 2024 World Series of Poker, and this will be where the high-profile final tables take place.

Paris Las Vegas Hotel

The Paris Las Vegas Hotel is also owned and operated by Caesars Entertainment. Opened in 1999 it is substantially younger than its neighbouring property and has 2,917 rooms and almost 100,000 square feet of gaming space. Themed around the French capital, the property features a half-scale replica of the Eiffel tower and a two-thirds sized Arc de Triomphe.

2024 WSOP Schedule

The 2024 WSOP schedule was released in late February, featuring 88 bracelet events. Be sure to check out here what's different about this year's schedule compared to previous years.

2024 World Series of Poker (WSOP) Registration

The World Series of Poker is yet to confirm details on how players can enter events at the 2024 WSOP in Las Vegas. However, the registration process is expected to be similar to 2024, details of which can be found below. No locations in the Horseshoe and Paris Las Vegas have been confirmed to be the area for registration or entering events.

Online and in-person registration for all World Series events will open in the weeks prior to the first event. Players will be able to register 24 hours a day, 7 days a week.

Players will need to bring a valid photo ID and your Caesars Rewards Loyalty card in order to register.

International players are required to bring an additional form of identification that shows residential address, such as a signed Las Vegas lease agreement, a utility bill or a mobile phone bill.

2024 WSOP Online Registration

Players will once again be able to use Bravo Poker Live to register for World Series of Poker bracelet events online.

Players will need to validate their identity before being able to register online. They must also have an active and valid Caesars Rewards account and Bravo Live account.

In 2024, players could then simply pick event(s) online via Bravo, utilizing the self-service kiosks located throughout the Rio Convention Center to print their seat cards, and go directly to their table.

It is unclear whether these kiosks will be available at the Horseshoe or Paris.

Na lista do tribunal: o retorno de dois dos casos criminais de Trump?

Promotor especial Jack Smith unibet sport Washington DC unibet sport 1 de agosto.

A sorte de Donald Trump com seus casos criminais pode ter terminado esta semana com a equipe do promotor especial Jack Smith lançando uma série de salvas que poderiam reviver duas investigações ameaçadas.

Smith apresentou uma nova acusação contra Trump no tribunal federal de Washington DC na terça-feira sobre os esforços do ex-presidente para reverter as eleições de 2024. Embora a movimentação de Smith não altere dramaticamente o caso contra Trump, a nova acusação poderia proteger o caso seguindo uma decisão do Supremo Tribunal de julho que ele e outros presidentes desfrutavam de ampla imunidade para atos oficiais.

"Hoje, um grande júri no Distrito de Columbia retornou uma acusação acusatória revisada, acusando o réu dos mesmos crimes criminais que foram acusados na acusação original", escreveram os advogados de Smith unibet sport documentos judiciais.

"A acusação acusatória revisada, que foi apresentada a um novo grande júri que não havia ouvido anteriormente provas neste caso, reflete os esforços do governo para respeitar e implementar as decisões do Supremo Tribunal e as instruções de remessa unibet sport Trump v Estados Unidos."

Os promotores enfatizaram unibet sport vários pontos que Trump estava atuando fora do escopo de suas obrigações oficiais. "O réu não teve responsabilidades oficiais relacionadas à certificação dos resultados das eleições de qualquer estado", escreveram. No dia anterior, a equipe de Smith solicitou a um tribunal federal de apelações que reinstalasse o caso de registros classificados, que o juiz Trump-nomeado Aileen Cannon descartou unibet sport 15 de julho. Eles argumentaram que a descarga de Cannon do caso - baseada unibet sport unibet sport crença de que o nomeamento de Smith foi inconstitucional - estava incorreto.

Lembre-se: Cannon sentiu que o nomeamento de Smith era ilegal porque ele era um nomeado externo, unibet sport vez de um funcionário do Departamento de Justiça confirmado pelo Senado, escreveu: "Como o exercício de poder de promoção de Smith não foi autorizado pela lei, o tribunal não vê outra forma além da descarga da acusação acusatória revisada."

No seu apelo de 81 páginas, os promotores argumentam que Cannon ignorou decisões judiciais anteriores. Eles insistem unibet sport seu apelo de que Cannon errou unibet sport se concentrar unibet sport se Smith já era um funcionário do Departamento de Justiça ou confirmado pelo Senado.

O procurador-geral, disseram eles, tem ampla autoridade para escolher promotores sob estatuto federal. E eles argumentaram ainda mais que Cannon estava incorreta unibet sport rejeitar um mínimo de quatro leis federais que autorizavam o nomeamento de Smith. Um deles, a seção 515 do título 28 do Código dos Estados Unidos, permite que um funcionário do Departamento de Justiça dos Estados Unidos lide com procedimentos legais quando "especialmente dirigido pelo procurador-geral sob lei", disseram eles.

Eles também apontaram que a seção 533 concede ao procurador-geral o poder de nomear funcionários para localizar e processar crimes contra este país, concedendo ao procurador-geral, Merrick Garland, o poder de nomear Smith como promotor especial para os procedimentos Trump.

Como observou o Guardian's Hugo Lowell, a briga legal sobre a questão do estatuto deve ser o ponto focal dos procedimentos de apelação. Promotores e advogados de Trump já se enfrentaram sobre os quatro estatutos durante uma audiência de vários dias na sala da vara de Cannon antes que ela descartasse o caso.

Ela sentiu que, enquanto a seção 515 permitia que o procurador-geral escolhesse quem quisesse para servir como promotor especial, ela aplicava apenas aos funcionários existentes do

Departamento de Justiça.

A apresentação de promotores ao Tribunal de Apelações do 11º Circuito dá início a uma batalha legal quase garantida que pode durar meses, se não anos. E, a decisão do 11º Circuito é provável que seja litigada mais a fundo no Supremo Tribunal dos Estados Unidos.

Após Smith arquivar papéis de apelação, comentaristas jurídicos estavam divididos sobre como a apresentação iria se desenrolar. Norm Eisen escreveu no X que o caso de Smith era forte, apontando para exemplos históricos de procedimentos de promotor especial.

"A decisão de Cannon de descartar o caso foi baseada numa leitura incorreta da constituição concluindo que o nomeamento de Smith para o cargo era ilegal. Todo o tribunal a considerar o assunto (incluindo o Supremo Tribunal) tomou uma posição diferente", escreveu Eisen no ``
